The objection deadline for each docket is no later than the Monday of the week prior to the particular docket day. The deadline and docket settings must be noticed pursuant to the Federal Rules of Bankruptcy Procedure.

Pleadings filed after the cutoff date will not appear on the docket. Notices that contain objection deadlines after the cutoff deadline will be considered defective, and counsel will be required to renotice the issue.

The stay docket can also be used for miscellaneous matters that need to be heard before the next scheduled docket for that particular chapter.

Only matters on confirmed cases may be set on the Misc. Ch. 13 Docket. No Ch. 13 non-stay issues should be set on the Ch. 7/11 Stay/Misc. Docket.
