**Ch. 13 Confirmation Docket Day** - Scheduled for 1:30 p.m.

**Miscellaneous Motions Docket Day**

- Ch. 7 cases scheduled for 9:00 a.m.
- Ch. 11/12 cases scheduled for 10:30 a.m.

## **STAY/DISMISSAL DOCKET CRITERIA**

The following are the only types of matters eligible to be noticed for a Stay Relief/Ch 13 Dism Docket day absent prior consent of the presiding judge.

- Motions For Relief From Stay - **All Chapters** [includes motions for relief which are combined with other relief types such as adequate protection, abandonment, etc.]
- Chapter 13 Trustee Motions To Dismiss (**Chapter 13 cases only**)

## **OBJECTION CUT-OFF DEADLINES**

Movants may establish objection deadlines for a particular motions docket any time prior to the Objection Cut-Off Date so long as proper notice has been given pursuant to Fed. R. Bankr. P. The objection deadline dates will always fall on the **Monday** of the **week prior** to the particular Stay Relief/Ch 13 Dism Docket day or Motions Docket day ***unless otherwise specified*** in the calendar information.
