Pursuant to District of Kansas Local Bankruptcy Rule 9029.3 and Standing Order 18-1, this court's Bankruptcy Bench Bar Committee consists of the chief judge, any other judges who may be appointed by the court, the United States Attorney or a designated assistant (permanent member), the U.S. Trustee for Region 20 or a designated assistant (permanent member), a Chapter 13 Trustee, a Chapter 7 Trustee, and six (6) actively practicing members of the bankruptcy court. The Bankruptcy Court may also appoint a Chapter 12 Trustee, as needed.
