Pursuant to District of Kansas Local Bankruptcy Rule 9029.3, this court's Bankruptcy Bench Bar Committee consists of the chief judge, any other judges who may be appointed by the court, the United States Attorney or a designated assistant (permanent member), the U.S. Trustee for Region 20 or a designated assistant (permanent member), a Chapter 13 Trustee, a Chapter 7 Trustee, and six (6) actively practicing members of the bar of the bankruptcy court.
