# Creditors May Use KSBFastFile

Creditors who do not have an account to file documents in the Electronic Case Filing (ECF) system may use the online KSBFastFile tools available at <a href="https://www.ksb.uscourts.gov/ksbfastfile">https://www.ksb.uscourts.gov/ksbfastfile</a> to electronically file a Proof of Claim, an Amended Proof of Claim, Withdrawal of a Proof of Claim, a Supplemental Claim, a Reaffirmation Agreement, or a Request for Notice.

Debtors who submit filing fee payments (including installment payments) must pay them by money order or cashier's check. Personal checks from debtors are not accepted.

Payments from persons other than debtors may be made by check, money order, or cashier's check.

Do not send cash.

#### Hearings Will Be Rescheduled or Conducted Telephonically

Hearings that are currently scheduled will be either rescheduled or conducted telephonically. Future hearings will be addressed as the conditions warrant. Case specific information will be provided in scheduling orders or otherwise communicated directly to the parties.
